Dates & Hours

Spring (*Traditional*): Tuesday, January 6th, 2026 to Thursday, June 25th, 2026.

State Psychomotor Exam: Saturday, June 27th, 2026.

Classes are on Tuesdays and Thursdays from 6:00 p.m. to 10:00 p.m.

Cost: \$1250.00

Summer (*Accelerated*): Monday, June 1st, 2026 to Friday, August 7th, 2026.

State Psychomotor Exam: Saturday, August 8th, 2026.

Classes are on Mondays, Wednesdays and Fridays from 9:00 a.m. to 4:00 p.m.

Cost: \$1500.00

Fall (*Traditional*): Tuesday, July 7th, 2026 to Thursday, December 10th, 2026.

State Psychomotor Exam: Saturday, December 12th, 2026.

Classes are on Tuesdays and Thursdays from 6:00 p.m. to 10:00 p.m.

Cost: \$1250.00



Tuition

Traditional tuition Includes: CPR Certification through the American Heart Association, Stop The Bleed ® Certification, course textbook, access to online course material with clinical scheduling and skills tracking, (1) long sleeve pullover and (2) uniform shirts needed for clinicals.

Accelerated tuition includes: CPR Certification through the American Heart Association, Stop The Bleed ® Certification, course textbook, access to online course material with clinical scheduling and skills tracking, cadaver lab, and (2) uniform shirts needed for clinicals.

The Hendricks Regional Health EMT Program is a certified **GI Bill® eligible training program**.

Enrollment

Program enrollment has a first-come, first-served entry for the first (20) applicants in each cohort to complete the application process and submit a tuition deposit. If more than (20) complete applications are submitted, a waiting list will be initiated.

1. Applicants must first complete a course application, found here:

2. Applicants must then submit copies of the following documents:
 - ✓ Driver's License or Government Identification
 - ✓ High School Diploma or Education Certificate
 - Applicants who have not yet graduated from high school will be asked to submit a transcript or diploma upon completion.
 - ✓ Indiana Limited Criminal History Report (<https://www.in.gov/ai/appfiles/isp-lch/>)
 - Applicants under the age of 18 will not be eligible for an Indiana Limited Criminal History Report, and should inform the program manager upon enrollment.
3. When all documents have been received and processed, you will receive a request for tuition payment.
 - a. **Traditional** program applicants will need to pay a \$625.00 deposit to reserve their seat in the program.
 - i. The remaining balance must be paid within (14) days of the beginning of the course.
 - ii. Full tuition may be paid up front, if preferred.
 - b. **Accelerated** program applicants will need to pay their tuition in full to reserve a spot in the class.



4. Once payment has been received, each accepted student will receive a welcome email with further information and details on the course, including the mandatory information meeting prior to the start of class, uniform requirements, and pre-course instructions.

Payment Options

Tuition may be paid by debit or credit through our online payment portal, or by check. A link to the online payment portal will be emailed upon acceptance into the program. Payments will not be accepted before program acceptance.

Additional Costs

- ✓ (1) Pair of navy blue or black work pants.
- ✓ (1) Pair of black, close-toed shoes or boots to wear during field clinicals.
- ✓ (1) 1/2" binder with a transparent insert cover.
- ✓ The National Registry of Emergency Medical Technicians (NREMT) online written examination application fee is \$104.00, and will be paid directly to the NREMT to sit for the written certification exam upon completing the program.

Clinical Experience

In addition to class lectures, students will complete field internship clinicals with one of our affiliated fire departments in and around Hendricks County.
